# 1. Welcome, Opening Remarks, Confirmation of Quorum, and Approval of Agenda and Previous Meeting's Minutes

Anthony Lakavage noted that a quorum was present. Dennis E. Doherty, CoC Chair, welcomed everyone to the eleventh meeting of the CoC for the 2020–2025 cycle and convened the meeting at 8:02 a.m. The Chair introduced Catherine Duggan as the newest CoC Member and newly appointed chair of the Europe Regional Chapter.

# a. Overview of Agenda

The Chair reviewed the meeting agenda. CoC Members provided no edits.

**Motion:** Emmanuel Akala moved to approve the meeting agenda. The motion was seconded and there was no discussion.

Vote: The motion carried by unanimous consent.

# b. Approval of Minutes from Previous Meeting

The Chair asked attendees if there were any corrections to the minutes of the April 19, 2023, CoC Meeting. CoC Members provided no edits.

Motion: Stephen Mullenix moved to approve the minutes of the April 19, 2023, CoC

meeting. The motion was seconded and there was no discussion.

**Vote:** The motion carried by unanimous consent.

# 2. Deep Dive: Asia-Pacific Economic Cooperation (APEC) Medical Product Supply Chain Dialogue

Anthony Lakavage provided an overview of the USP-APEC Center of Excellence, the APEC Supply Chain Security Toolkit, and the APEC Medical Product Supply Chain Dialogue event co-hosted by FDA and USP at USP-Rockville, MD, on April 25–26, 2023. He summarized the key themes of the keynote address and APEC panel discussions. John Lim noted the value of regional collaboration among regulators and stakeholders at the Asia Pacific (APAC) Regional Chapter meeting held April 27, 2023, at USP-Rockville in support of supply chain resilience and regulatory lessons for pandemic preparedness. Carrie Harney noted the public health benefits and risks of online pharmacies and that communication,



collaboration, and compliance with the APEC Toolkit can help overcome these challenges. Anthony Lakavage noted that USP welcomes ideas from CoC Members on promoting the APEC Toolkit and that CoC Members are welcome to link to the APEC Supply Chain Toolkit on their websites.

#### Discussion

A CoC Member noted that USP staff should include general practitioners as recipients of the toolkit. Another CoC Member suggested that discussions on stockpiles might result in recommendations for reducing drug shortages. USP staff replied that USP has made recommendations to the U.S. Department of Health & Human Services' Administration for Strategic Preparedness & Response. A CoC Member noted that USP's Medicine Supply Map makes drug shortages more transparent and may help avoid unnecessary stockpiling.

# 3. Convention Sector and Chapter Updates

The Chair called on Amy Sonderman for an introduction of the Sector and Chapter speakers. John Lim summarized the key takeaways from the APAC Regional Chapter meeting. Jay Sirois provided updates on the Dietary Supplements and Healthcare Practice Sectors Joint Meeting held on June 22, 2023, and the launch of the "Choosing for Quality: Dietary Supplements" resource. He noted that CoC Members who have contacts or colleagues who might benefit from USP's dietary supplements resource can contact Darcy Gentleman. Ilisa Bernstein provided updates on the May 23, 2023, Healthcare Practice Sector luncheon meeting. She provided an update on pictograms for fall 2023. Susan Cantrell described the success of the Infographic on Biosimilars Quality, which rolled out in 2022, and provided updates on the Biosimilar User Fee Act III regulatory research roadmap discussion with FDA.

# 4. New Convention Member Approvals

**Motion:** David Gaugh moved to recommend to the Board of Trustees approval of the three organizations as new Voting Members of the USP Convention. The motion was seconded. No conflicts were declared and there was no discussion.

Vote: The motion was unanimously adopted.

# 5. Launching the 2025–2030 Resolutions Process

Shelley Whiddon provided an overview of the CoC's responsibilities related to the 2025–2030 Resolutions process and summarized the CoC's related responsibilities.

## **Discussion**

USP staff noted that there is a concurrent process in which the Board of Trustees works with USP staff to develop a proposed strategy in tandem with the Resolutions development process, which will be shared with attendees of the upcoming Volunteer Leadership Meeting (VLM). A CoC Member commented that the number of Resolutions proposed for the 2025–2030 cycle should be discussed. In response to questions from a CoC Member, USP staff clarified the process for developing and approving the Resolutions and noted that they will share the dates of the Spring 2025 Convention Meeting with CoC Members when the information is finalized.

Shelley Whiddon provided an update on the Bylaws Committee's composition and next steps.
